



Food Vendor Agreement Form

Thanks for supporting the Mole & Mariachi Festival at Santa Cruz Mission State Historic Park!

GUIDELINES

1. The fee to have a food booth is \$500.
2. A limited number of premium stage-facing food booths are available for an additional fee of \$50.
3. Vendors handle their own money and transactions.
4. Large-print menus must be posted in at least one location on the booth.
5. Menus must be limited to facilitate quick service.
6. Food vendors are strongly encouraged to have a mole dish.
7. Food vendors must provide all booth needs, including heating elements, tables, chairs, etc.
8. Propane cooking is permitted. No electricity will be provided at the festival and generators are prohibited.
9. Pop-up shade tents are recommended and must be provided by food vendors.
10. Booths must be staffed by at least two people.
11. Friends is striving to have a zero-waste event – more information will be provided and participation is strongly encouraged.
12. Load-in will be Friday afternoon (Sept. 6) and Saturday morning (Sept. 7). You will be assigned a time. The festival provides an overnight security guard to patrol the enclosed, locked park. Vehicle access to the site will be closed at 9:30 am the day of the festival.
13. Friends of Santa Cruz State Parks may use photos or videos of vendor and staff at the Festival for publicity purposes.
14. Space is first-come, first-served and will sell out.
